The Trunk Road (Rhayader, Powys) (40 m.p.h. Speed Limit and Restricted Road) Order 1979

Notice is hereby given that the Secretary of State for Wales Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 72, 73 and 74 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968. The effect of the Order will be that no person shall drive any motor vehicle at a speed exceeding 40 m.p.h in the length of trunk road specified in Schedule I to this notice and no person shall drive ary motor whicle at a creat droeding 20 m p h in the

drive any motor vehicle at a speed exceeding 30 m.p.h. in the length of trunk road specified in Schedule II to this notice. That length of the Cardiff-Glan Conwy Trunk Road (A470) at Rhayader in the county of Powys which extends from a point 165 yards north of its junction with Tanner's Row in a general northerly direction for a distance of 433 yards.

SCHEDULE II

That length of the Cardiff-Glan Conwy Trunk Road (A470) at Rhayader in the County of Powys which extends from a point 98 yards north of its junction with Tanner's Row in a general northerly direction for a distance of 67 vards.

The Trunk Road (Talgarth, Powys) (Prohibition and Restriction of Waiting) Order 1979

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Trans-port Act 1968 and Schedule 6 to the Road Traffic Act 1974, which shall come into operation on 1st March 1979. The effect of the Order will be:

(a) to prohibit waiting on the sides of road specified in

Schedule 1 to this notice, and (b) to restrict waiting on the side of road specified in Schedule 2 to this notice to 30 minutes in any one hour between 8 a.m. and 6 p.m. on any day other than a Sunday.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building, indus-trial or demolition operation, the removal of any obstruction to traffic, or the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local or water authority in pursuance of statutory powers or duties.

An exception will also be provided in the Order to allow vehicles bearing both a disabled person's badge and a parking disc to wait on the sides of road specified in Schedule to this notice for a period not exceeding two hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road.

An exception will also be provided in the Order to allow vehicles bearing a disabled person's badge to wait on the side of road specified in Schedule 2 to this notice. A copy of the Order, together with a plan and a state-ment of reasons for making the Order, may be seen during normal office hours at the offices of the Powys County Council, Highway Depot, Hall Road, Talgarth, during a period of six weeks from 1st March 1979.
