#### PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 14th March 1979 by Order in Council to confirm the following Schemes made by the Church Commissioners

- 1. Uniting the benefices of Saint Mary with Saint John, Bootle; and Saint Paul, North Shore and uniting the parishes of Saint Mary, Bootle; Saint John, Bootle; and Saint Paul, North Shore in the diocese of Liverpool.

- 2. (1) Creating a new benefice of Legsby;
  (2) altering the name of the benefice of Legsby with
  North Willingham; and
  (3) holding in plurality the benefices of Market Rasen; Linwood; and the new benefice of Legsby, in the diocese
- 3. (1) Dissolving the benefices of All Saints, Weston-super-Mare; and Saint Saviour, Weston-super-Mare; (2) transferring the parishes of All Saints, Weston-super-Mare and Saint Saviour, Weston-super-Mare to the benefice of Weston-super-Mare Central Parishes, and
- (3) amending the provisions of an earlier Scheme establishing a team ministry for the benefice of Weston-super-Mare Central Parishes, in the diocese of Bath and Wells.
- 4. Uniting the benefices and parishes of Corsham; and Saint Philip and Saint James, Neston, in the diocese of Bristol, and establishing a team ministry for the area of the new benefice.
- 5. Uniting the benefices of Witton-le-Wear; and Fir Tree, in the diocese of Durham.
- 6. Uniting the benefices of Wragsby with Panton; Langton by Wragby; Goltho with Bullington; and Rand with Fulnetby, in the diocese of Lincoln, and uniting the parishes of Wragby and Panton; and the parishes of Goltho with Bullington and Rand with Fulnetby.
- 7. Uniting the parishes of Tidcombe and Fosbury, in the diocese of Salisbury, and declaring redundant the parish church of the parish of Fosbury.
- 8. Uniting the benefices of Rye with Rye Harbour and Playden; and Iden, in the diocese of Chichester.
- 9. Appropriating the redundant church of Saint James the Less, East Hanney, a former chapel of ease in the parish of Hanney, in the diocese of Oxford, and the land annexed
