#### THE PUBLIC SCHOOLS ACT 1868

THE GOVERNING BODY OF SHREWSBURY SCHOOL having, on the 9th day of March 1979, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that

behalf contained in the said Act.

And notice is hereby given, that any person, body of persons, or body corporate, authorised in that behalf by the said Act, may, within 2 months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of

the said Statute.

STATUTE made by the Governing Body of Shrewsbury School on the 9th day of March 1979.

We, the Governing Body of Shrewsbury School (otherwise Shrewsbury Free Grammar School) do hereby in exercise of the powers of section 11 of the Public Schools Act 1968, and the Acts amending the same and all other powers enabling us in that behalf enact as follows:

Amendment to Statute III, The Headmaster

Paragraph 2 shall be deleted and there shall be substituted therefor the words "He shall be a graduate of a British University

Whereas a Representation duly made to Her Majesty in Council by the Secretary of State for the Environment that Council by the Secretary of State for the Environment that burials should be discontinued as hereinafter directed in Tettenhall (St. Michael and All Angels) Churchyard, Tettenhall, in the County of West Midlands, has, in pursuance of an Order in Council made the 6th day of February 1979 and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853 c. 134, and of all other powers Her enabling, is pleased by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. Burials shall be discontinued forthwith in Tettenhall (St. Michael and All Angels) Churchyard, Tettenhall, in the County of West Midlands, shown hatched on the plan

Provided that-

(a) in any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the
