
condition that every coffin buried in such vault or grave be separately enclosed by stone-work or brickwork properly cemented;

(b) in any earthen grave now existing in the said Churchyard, the burial may be allowed for the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds Tettenhall (St. Michael and All Angels) Churchyard, Tettenhall, West Midlands Order 1979.

3. The Bills will be issued and paid at the Bank of England.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Tenders must be made on the printed forms which may be obtained from the Bank of England.

8. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

# TENDERS FOR TREASURY BILLS

1.
