NOTICE OF PROPOSALS OF THE THAMES WATER AUTHORITY FOR THE VARIATION OF LICENCE TO ABSTRACT WATER.

Notice is hereby given that the Thames Water Authority have made proposals for the variation of licence to abstract water No. 28/39/23/134.

The licence, as granted, authorises the abstraction of 75,000 gallons per hour, 1.8 million gallons per day and 584 million gallons per year by means of a borehole in underground strata (chalk) at National Grid Reference SU 739 762 at the Authority's Pumping Station at Playhatch, Oxon. The Authority now propose that the licence No. 28/39/23/ 134 should be varied so as to authorise abstraction from the strata by means of a further borehole at National Grid Reference SU 739 762 in addition to the existing borehole. No increased quantities of water are sought to be authorised to be abstracted.

OTICE OF APPLICATION FOR LICENCE TO OBSTRUCT OR IMPEDE THE FLOW OF AN IN-LAND WATER BY MEANS OF IMPOUNDING NOTICE

Notice is hereby given that an application is being made to the North West Water Authority by British Nuclear Fuels Limited for a licence to obstruct or impede the flow of Wastwater Lake by means of a weir of up to 3 feet 4 inches above natural bar level associated with raising the average lake level of 200 AOD up to 202 AOD at about NGR 144038 on OS Sheet NY10 as shown on the plan to accompany the application.

The object of impounding water by means of the works is the provision of additional reservoir capacity in association with the application to vary abstraction licence serial number 27/74C/7/L/11, submitted to the North West Water Authority by British Nuclear Fuels Limited and dated 11th April 1979.

The capacity of the reservoir at overflow level will be increased by approximately 650 million gallons above bar

level.

This application will be submitted in order to allow for methods that would provide the onsideration of various methods that would provide the quantity of water sought by BNFL—impounding by the construction of a weir up to 3 feet 4 inches above natural bar level, drawing down the level of the lake, or a combination thereof. The applicant is prepared to implement whichever method meets the public interest.
