Pursuant to section 139 (6) of the Customs and Excise Management Act 1979 and paragraph 1 of the 3rd Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely one Snowgoose catamaran yacht, "Havcat", with all contents and equipment have been seized as liable to forfeiture upon the grounds that:
