REVISED NOTICE

*Kingswood District Council, Kingswood, Bristol, Kingswood
(No. 1) Noise Abatement Zone 1979, Bitton Area*

Notice is hereby given that the Kingswood District Council in exercise of the powers conferred on them by section 63 of the Control of Pollution Act 1974, have, by Order, declared part of Bitton to be a noise abatement zone. The Order relates to commercial and industrial premises within the zone.

The proposed zone straddles High Street and Bath Road, Bitton. It is approximately bounded on the east side by Golden Valley Lane, Aubrey Meads and Church Lane, on the north and west by the River Boyd, Tayman Ridge and Kings Square and to the south by a line running roughly due west from the Old Vicarage, Church Lane.

The main purpose of a noise abatement zone is to limit noise emissions from designated premises within the zone to existing levels and to ensure that increases do not occur except with the written consent of the local authority. In prescribed circumstances where the noise emissions are considered to be excessive then powers are available to bring about a reduction in the measured levels.

A copy of the Order and a plan showing the proposed zone and the designated premises will be on show during normal office hours, 8.45 a.m.—1 p.m. and 2 p.m.—5 p.m. Mondays to Fridays, at the Environmental Health Department, High Street, Kingswood, Bristol and may be inspected by any person free of charge during the 6 weeks from the date of publication of this notice.

HARTLEPOOL BOROUGH COUNCIL

THE CLEAN AIR ACT 1956

*The Borough of Hartlepool, No. 36 Smoke Control Order
1979*

Notice is hereby given that the Hartlepool Borough Council in exercise of the powers conferred upon them by section 11 of the above-mentioned Act on 29th May 1979 made an Order entitled the Borough of Hartlepool No. 36 Smoke Control Order 1979 declaring the area described in the Schedule hereto to be a smoke control area which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11(4) of the Act if on any days after the Order has come into operation smoke is emitted from a chimney of any building within the smoke control area the occupier of the building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed the Order will not come into operation before 1st November 1980 or such later date as may be determined by the Secretary of State for the Environment.

Copies of the Order and of the map referred to therein may be inspected free of charge at the offices of the Borough Solicitor, Civic Centre, Victoria Road, Hartlepool during normal office hours during the period of 6 weeks from 14th June 1979.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary of State for the Environment, 2 Marsham Street, London SW1P 3EB object to the confirmation of the Order.

SCHEDULE

The area situate in the Borough of Hartlepool bounded by the centres of West View Road, Cleveland Road, the main Hartlepool to Sunderland railway line, north-eastwards along the disused railway embankment, the centre of Old Cemetery Road, then north-eastwards along the boundary of Smoke Control Area No. H3, following the high water mark to meet the boundary of Smoke Control Area No. 17 and then inland along this boundary, which area is more particularly shown coloured green on the map sealed with the Common Seal of the Hartlepool Borough Council and marked "Map referred to in the Borough of Hartlepool No. 36 Smoke Control Order 1979".
