SECTION 9 (6) OF THE LAND DRAINAGE ACT 1976

Welsh Water Authority

An application having been received from the Welsh Water Authority for the variation of the main river map of their area, the Secretary of State for Wales in pursuance of section 9 (6) of the Land Drainage Act 1976, hereby gives notice of his intention to vary the said main river map in accordance with the proposals described below.

The effect of the proposals will be to confer on the Welsh Water Authority alone the power to exercise certain land drainage and flood prevention functions (including maintenance) in relation to the added watercourses.

Additions

1. *Stretford Brook*, Stretford Parish, Leominster District, Hereford and Worcester.

2. *Honeylake Brook*, Leominster Parish, Leominster District, Hereford and Worcester.

3. *Moreton Brook*, Marden Parish, South Hereford District, Hereford and Worcester.

Plans bearing the reference WYA3 on which the proposals are more precisely defined by lines in green colour have been deposited for public inspection at the offices of the Chief Executive and Town Clerk, Hereford City Council, Town Hall, Hereford; at the offices of the Administration Officer, Leominster District Council, Barclays Bank Chambers, Broad Street, Leominster; at the offices of the Chief Executive, Welsh Water Authority, Cambrian Way, Brecon, Powys; at the offices of the Divisional Engineer, Welsh Water Authority, Wye Division, 4 St. John's Street, Hereford; and at the offices of The Welsh Office Agriculture Department, Room 320, Plas Crug, Aberystwyth, Dyfed, during normal office hours within the period of 31 days from the date of publication of this notice.
