The Restrictive Practices Court  
(In England and Wales)  
1979 No. 1 (E. & W.)

In the Matter of the RESTRICTIVE TRADE PRACTICES ACT 1976 and in the Matter of an Agreement between Members of the Stock Exchange. Notice is hereby given, pursuant to Rule 5 (2) (c) of the Restrictive Practices Court Rules 1976, that on 9th February 1979, there was issued out of the Restrictive Practices Court (in England and Wales) by the Director General of Fair Trading, pursuant to section 1 (3) of the Restrictive Trade Practices Act 1976, a Notice of Reference referring the above-mentioned Agreement being No. S.393 in the Register of Agreements maintained under section 1 (2) of the said Act.

And notice is hereby further given that, pursuant to Rule 5 (1) of the said Rules the said Director General has nominated the Stock Exchange, London EC2N 1HP as Representative Respondent to represent (for the purpose of all proceedings in the above matters) all parties to the said Agreement on and after 22nd March 1976.

The Stock Exchange if it objects to being made Representative Respondent or any party to the said Agreement who objects to being represented by the said Stock Exchange may, pursuant to Rule 6 of the said Rules, apply by notice in writing within 28 days of the publication of this notice to the Restrictive Practices Court, Royal Courts of Justice, Strand, London W.C.2, for an Order revoking or modifying the nomination and for such other directions as may be specified in any such application.
