### NEW TOWNS ACT 1965

#### *Extinguishment of Public Rights of Way Donnington in the New Town of Telford*

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1965, has made an Order extinguishing the public rights of way over the following highways shown by a dotted line on the map referred to therein:

That part of Footpath No. 40 starting from a point marked "A" on the map approximately 120 metres north-east of its junction with Church Road and extending in an easterly direction for a distance of approximately 90 metres to a point marked "B" on the map.

Footpath No. 36 starting from a point marked "C" on the map approximately 80 metres east of the junction of Bradley Road and St. Georges Road and extending in a south-easterly direction for a distance of approximately 260 metres to a point marked "E" on the map at its junction with Footpath No. 37.

Footpath No. 37 to be closed from point "E" at its junction with Footpath No. 36 for a distance of 155 metres to its termination at point "D" approximately 480 metres south-east of the junction of Bradley Road and St. Georges Road.

Notice is hereby given, pursuant to section 353 (5) of the Companies Act 1948, that the names of the undermentioned Companies have been struck off the Register.
