The western boundary runs southwards to include the warehouses on the west bank of the river as far as the Great North Road. The southern boundary follows the northern boundary of the existing Conservation Area from the Great North Road to Bede House Lane. The eastern boundary runs north to include the grounds of Newark Technical College, then follows Friary Road to its junction with Sleaford Road.

In addition, anyone intending to cut down, top or lop any tree in a Conservation Area must give the District Council 6 weeks' notice of his intention.
