NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER  
HIGHWAYS ACT 1959

*The Cumbria County Council (Footpath No. 345040, Matterdale) Public Path Extinguishment Order, 1979*

Notice is hereby given that on 24th July 1979, the Cumbria County Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public right of way running from the west side of the Matterdale End-Ullswater Road C3038 at a point approximately 30 metres north-west of its junction with road No. C3136, generally north-westwards for approximately 190 metres across O.S. Field No. 2486 and through All Saints' Churchyard to join the private road leading to the Rectory approximately 70 metres from the junction with Road No. C3038.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Post Office, Pooley Bridge, and at the offices of the Chief Executive, Eden District Council, Town Hall, Penrith, during opening hours.

The Order became operative as from 31st July 1979 but if a person aggrieved by the Order wishes to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the grounds that any requirement of the Act, as amended, or of any regulation made thereunder has not been complied with in relation to the Order, he may under paragraph 2 of Schedule 2 of the Act, as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 17th August 1979 make an application for the purpose to the High Court.

*Mid Devon District Council Public Footpath No. 7 (Clannaborough) Diversion Order 1979*

Notice is hereby given that on 6th August 1979, the Secretary of State for the Environment confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way which crosses fields Nos. 0002, 2700 (turning eastwards at Combe Fish Pond) 4232 and 5338 before terminating on the Public Highway opposite St. Petrock's Church to a line following an existing track on the eastern boundary of fields Nos. 0002, 0007 and 1347 for approximately 600 metres before turning at right angles and following the boundary of field No. 5338 to its conclusion.
