cumstances, shall (both as respects this order and as respects the interim preservation notice superseded by this order) in default of agreement be determined by the Lands Tribunal as may appear to the Tribunal to be

just.

4. This order may be cited as the Barnsley Park Roman Villa and Field System Preservation Order 1979 and 1979.
