#### **PASTORAL MEASURE 1968**

Notice is hereby given that Her Majesty was pleased on 19th October 1979 by Order in Council to confirm a Scheme made by the Church Commissioners for:

1. Uniting the benefices of Offenham and Bretforton, in the diocese of Worcester.

2. Uniting the benefices of Clipston; Naseby and Hasel-bech, in the diocese of Peterborough.

3. Uniting the benefices of Broughton Sulney; Hickling; and Kinoulton, in the diocese of Southwell.

4. Declaring redundant the church of Holy Trinity, a chapel of ease in the parish of Horncastle, in the diocese of Lincoln.

5.--(1) Dissolving the benefice of Mavis Enderby with Raithby ;

(2) creating new benefices of Mavis Enterby; and Raithby;

- (3) uniting the benefices of Bolingbroke with Hareby; Miningsby with East Kirkby; Hagnaby; Hagworthing-ham with Asgarby and Lusby; and the new benefice of Mavis Enderby; and
- (4) holding in plurality the benefices of Spilsby with Hundleby; Aswardby with Sausthorpe; Langton with Sutterby; Halton Holgate; Firsby with Great Steeping; Little Steeping and the new benefice of Raithby, in the diocese of Lincoln.

6. Declaring redundant the parish church of the parish of Saint Jude, East Brixton, in the diocese of Southwark.

- 7.--(1) Creating the new parish of Saint Peter, Langley Burrell,
- (2) uniting the parish of Saint Paul, Chippenham, with Langley Burrell; and Saint Peter, Langley Burrell;
  (3) uniting the benefice of Saint Paul, Chippenham,
- with Langley Burrell; and Hardenhuish;
- (4) establishing a team ministry for the area of the said new benefice, and

(5) holding in plurality the said new benefice and the benefice of Kington Saint Michael, in the diocese of Bristol.

8.--(1) Uniting the benefices of Kingston and Broomfield;

- (2) altering the name of the parish of Kingston; and (3) uniting the new benefice at (1) with the benfice of
- Cheddon Fitzpaine, in the diocese of Bath and Wells. 9. Appropriating the redundant church of Christ Church,

Gailey, in the diocese of Lichfield, to use as a craft workshop and for purposes ancillary thereto; and empowering the said Commissioners to sell the said building for such uses.

10. Approaching the redundant parish church of the parish of Alresford, in the diocese of Chelmsford, to use as a monument and for purposes ancillary thereto; and empowering the said Commissioners to give the said building for such uses.

11. Uniting the benefices of Husbands Bosworth with Mowsley and Knaptoft; and Theddingworth, in the diocese of Leicester.

12. Uniting the benefices of Foxton with Gumley and Laughton; and Lubenham, in the diocese of Leicester.

13. Uniting the benefices of Ashprington; Cornworthy; and Dittisham, in the diocese of Exeter.

14. Uniting the benefices of Cattistock with Chilfrome and Rampisham with Wraxhall; Corscombe; Evershot, Frome Saint Quinton, Melbury Bubb and Melbury Osmond with Melbury Sampford; and Halstock and The Chel-boroughs, in the diocese of Salisbury; and establishing a team ministry for the area of the new benefice.

15. Uniting the benefices of Heanton Punchardon; and Marwood, in the diocese of Exeter.

16. Uniting the benefices of Kempsey ; and Severn Stoke with Croome d'Abitot, in the diocese of Worcester.

17. Uniting the benefices of North and South Ottering-ton; and Thornton le Street with Thornton le Moor and Thornton le Beans, in the diocese of York.

18. Appropriating part of the churchyard of the church of Saint Luke, Tutshill, in the parish of Tidenham with Lancaut, in the diocese of Gloucester; to use as a garden for a private dwelling house and vesting the land in the Gloucester Diocesan Board of Finance Ltd. for disposal.

19. Declaring redundant the parish church of the parish of Akeley, in the diocese of Oxford.

20. Appropriating the remains of the redundant church of Saint Mary the Virgin, in the parish of Eastwell, in the diocese of Canterbury, and the land annexed or belonging thereto, to use as a shrine or monument or for Christian community purposes and for purposes ancillary thereto;
