## New Towns Act 1965

Order for the Extinguishment of Public Rights of Way Washington Development Corporation

County of Tyne and Wear

Whereas (1) by virtue of section 23 (1) of the New Towns Act 1965, the Secretary of State for the Environment (hereinafter called "the Secretary of State") may by order extinguish any public rights of way over land which has been acquired and is for the time being held by a development corporation for the purposes of the New Towns Act 1965;

(2) The Washington Development Corporation has applied to the Secretary of State for an Order extinguishing the

to the Secretary of State for an Order extinguishing the public rights of way over the roads described in the schedule hereto, shown coloured pink and the footpath shown coloured brown on the map, being rights of way to which the

said Act applies;
(3) The Secretary of State has caused a notice to be published in accordance with the provisions of section 23 (2) of the said Act, and no objection to the proposal has been

made;

Now therefore, the Secretary of State, in exercise of the powers given to him in that behalf, hereby orders as follows

- 1. The public right of way over the roads described in the schedule hereto and shown coloured pink and the footpath shown coloured brown on the map, shall be extinguished as from the date of this Order.
- 2. The expression "the map" means the map prepared in duplicate, signed by a Senior Principal in the Department of the Environment and marked "map referred to in the County of Tyne and Wear (Washington Development Corporation: Footpath No. 40 and associated roads at Pattinson South Industrial Estate) Rights of Way Order 1979", one duplicate of which is deposited and available for inspection at the offices of the Washington Development Corporation, Usworth Hall, Stephenson, District 12, Washington, Tyne and Wear NE37 3HS, and the other at the offices of the Secretary of State.
- 3. This Order may be cited as the County of Tyne and Wear (Washington Development Corporation: Part of Footpath No. 40 and associated roads at Pattinson South Industrial Estate) Rights of Way Order 1979.

(i) Footpath No. 40, extending from a point north-west of Jubilee Terrace marked K on the map and running in a westerly direction for 285 metres to a point marked J on

(ii) A road extending from a point marked A on the map fronting Wilden Terrace, running in a south-westerly then north-westerly direction for 515 metres to a point south-east

(iii) A road extending from a point marked B on the map running in a north-westerly direction for 35 metres to a point marked F on the map, then running in a south-westerly direction for 125 metres to a point marked G on the map. the map.

(iv) A road extending from a point marked C on the map running in a southerly direction for 100 metres to a point

marked J on the map.

(v) A road extending from a point marked D on the map running in a north-westerly direction for 225 metres to a point east of Blythes Brickworks marked H on the map.

(vi) A road extending from a point marked F on the map running in a north-westerly direction for 60 metres to a point marked L on the map.
