METROPOLITAN AND CITY POLICE DISTRICTS

THE STREET COLLECTIONS (METROPOLITAN POLICE DISTRICT) REGULATIONS 1979

Made -

2nd October 1979 Coming into Operation ---1st January 1980

In pursuance of section 5 of the Police, Factories, etc. (Miscellaneous Provisions) Act 1916 (1916 c. 31 as amended by 1972 c. 70 (Sch. 29, para. 22)) I hereby make, as the police authority for the Metropolitan Police District, and I hereby confirm, the following Regulations:

1.—(1) These Regulations may be cited as the Street Collections (Metropolitan Police District) Regulations 1979, (2) These Regulations shall be published in the London Gazette on a day not later than 15th November 1979 and shall come into operation on 1st January 1980.

2. In these Regulations, unless the context otherwise requires-

" chief promoter " means a society, committee or other body consisting of not less than three persons to which a permit " collection has been granted; " collecting box " means a box or other receptacle for the reception of money from contributors; " Commissioner " means the Commissioner of Police of the Metropolis;

" collection " means-

(i) a collection of money; or

(ii) a sale of articles

in any street or public place within the Metropolitan Police District for the benefit of charitable or other purposes, and collector" shall be construed accordingly; "contributor" means a person who contributes to a collection, and includes a purchaser of articles for sale for the

benefit of charitable or other purposes; "permit" means a permit for a collection; "promoter" means a person, authorised in that behalf by the chief promoter, who causes others to act as collectors.
