PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 30th October 1979 by Order in Council to confirm Schemes made by the Church Commissioners for:

1. Appropriating the redundant parish church of the former parish of Saint Mark, Victoria Docks, in the diocese of Chelmsford, and the land annexed or belonging thereto, to use for cultural and community purposes and for storage, and empowering the said Commissioners to give the said building and land for such uses.
2. Appropriating the redundant church of Saint Thomas a Becket, Heptonstall (known as Heptonstall Old Church) in the diocese of Wakefield, to use as a monument and for purposes ancillary thereto and empowering the said Commissioners to give the said building for such uses.
