NOTICE OF PROPOSAL TO MODIFY PUBLIC PATH ORDER

*Rochdale Borough Council (Wolstenholme Lane, Norden)
Public Path Diversion Order 1978*

Notice is hereby given pursuant to paragraph 3 (2) of Schedule 20 to the Town and Country Planning Act 1971 that the Secretary of State for the Environment proposes to modify the Rochdale Borough Council (Wolstenholme Lane, Norden) Public Path Diversion Order 1978 by providing that part of the alternative path shall pass to the west of an electricity sub-station adjacent to Edenfield Road in a generally south-south-easterly direction for approximately 43 metres via a path alongside a proposed dwelling-house.

A copy of the Order and map as submitted and a copy of a map showing the proposed modification have been deposited at the Information Office, Town Hall, Rochdale, and may be inspected free of charge during normal office hours.

EXTINGUISHMENT OF PUBLIC RIGHTS OF WAY
