PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 14th November 1979 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Declaring redundant the church of Saint Peter, Parmentergate, Norwich, and making the chapel of ease of Saint John-the-Baptist, Timberhill, a parish church, in the diocese of Norwich.

2. Uniting the benefices of Pyworthy with Pancraswyke; and Bridgerule, and altering the name of the parish of Pyworthy with Pancraswyke, in the diocese of Exeter.

3. Providing for the demolition of the redundant parish church of the former parish of Miningsby, in the diocese of Lincoln; and appropriating its site to use as part of the surrounding churchyard.

4. (1) Creating a new benefice of Little Finborough; (2) uniting the said new benefice and the benefice of Hitcham; (3) uniting the benefices of Barking with Darmsden and Great Bricett; and Ringshall with Battisford and Little Finborough; and (4) declaring redundant the church of Saint Andrew, Darmsden, a chapel of ease in the parish of Barking with Darmsden, in the diocese of Saint Edmundsbury and Ipswich.

5. Appropriating the redundant parish church of the former parish of Ham, in the diocese of Canterbury, and the land annexed or belonging thereto, to use as a residence and stained glass workshop and for purposes ancillary thereto, and empowering the said Commissioners to sell the said building and land for such uses.

6. Declaring redundant the parish church of the parish of Holy Trinity with Saint Paul, Paddington, in the diocese of London.

7. Uniting the benefices of Henstridge; and Charlton Horethorne with Stowell, in the diocese of Bath and Wells.

8. Uniting the benefices of Burbage and Savernake Christchurch; Chute with Chute Forest; The Collingbournes and Everleigh; East Grafton, Tidcombe and Fosbury; and Shalbourne and Ham, in the diocese of Salisbury; and establishing a team ministry for the area of the new benefice.

9. Uniting the benefice of Ashill; and Saham Toney, in the diocese of Norwich.

10. Uniting the benefices of Exminster and Kenn, in the diocese of Exeter.

11. Uniting the benefices of Skipsea with Ulrome; and Barmston with Fraisthorpe, in the diocese of York; and uniting the parishes of Barmston and Fraisthorpe.

12. (1) Appropriating the redundant church of Holy Trinity, Tunbridge Wells, in the diocese of Rochester, and part of the land annexed or belonging thereto, to use as a theatre, arts and community centre, and for purposes ancillary thereto; (2) empowering the Rochester Diocesan Board of Finance to lease the said building and land for such uses; (3) appropriating a further part of the land annexed or belonging to the said church to use as part of the site of a proposed new place of worship and for car parking and (4) empowering the said Commissioners to give the said land for such uses.

13. Appropriating the redundant parish church of the parish of Ellerton Priory, in the diocese of York, to use as a joiner's workshop and for purposes ancillary thereto;

and empowering the York Diocesan Board of Finance to lease the said building for such uses.

14. Appropriating the redundant parish church of the former parish of Frenze, in the diocese of Norwich, to use as a shrine and monument or for Christian community purposes; and empowering the Norwich Diocesan Board of Finance to lease the said building for such uses.

15. (1) Creating a new benefice of Wingfield, in the diocese of Saint Edmundsbury and Ipswich; (2) uniting the benefices of Fressingfield with Weybread; and Wingfield; and (3) uniting the benefices of Hoxne with Denham (Saint John); and Wingfield and Syleham, in the diocese of Saint Edmundsbury and Ipswich.

16. (1) Transferring the parish of The Lea from the benefice of Aston Ingham with The Lea to the benefice of Hope Mansell; (2) uniting the benefices of Linton with Upton Bishop; and Aston Ingham with The Lea; (3) uniting the benefices of Weston under Penyard; and Hope Mansell, and (4) altering the name of the parish of Hope Mansell, in the diocese of Hereford.

17. (1) Uniting the benefices of Fawley; Fingest; Hambleton; Medmenham; and Turville, and (2) altering the name of the parish of Hambleton, in the diocese of Oxford.

18. Providing for the demolition of the redundant church of Saint John the Baptist, Stockton-on-Tees, in the diocese of Durham; and empowering the said Commissioners to sell or lease its site and the land annexed or belonging thereto.

19. Providing for the demolition of the redundant parish church of Saint Mary the Virgin, Burham, in the diocese of Rochester, and empowering the said Commissioners to dispose of its site and the land annexed or belonging thereto.

20. (1) Uniting the benefices of Wotton and Saint Mary, Holmbury, in the diocese of Guildford; (2) altering the name of the parish of Saint Mary, Holmbury; and (3) establishing a group ministry for the new benefice and the benefice of Abinger-cum-Cold Harbour.

21. (1) Altering the names of the parishes of Burton Bradstock with Shipton Gorge and Chilcombe; and Puncnoll, in the diocese of Salisbury; (2) uniting the benefices of Burton Bradstock with Shipton Gorge and Chilcombe; Litton Cheney; Long Bredy with Little Bredy; and Puncnoll with Swyre; and (3) establishing a team ministry for the area of the new benefice.

22. (1) Uniting the benefices of Barford Saint Martin; Dinton; and Baverstock; (2) transferring the parish of Compton Chamberlayne to the new benefice from the benefice of Fovant with Compton Chamberlayne and Sutton Mandeville; (3) uniting the benefices of Teffont Evias with Teffont Magna; and Fovant with Compton Chamberlayne and Sutton Mandeville, and (4) establishing a group ministry for the benefices of Burcombe and the two said new benefices, in the diocese of Salisbury.

The QUEEN'S Most Excellent Majesty in Council

Whereas a Representation duly made to Her Majesty in Council by the Secretary of State for the Environment that burials should be discontinued as hereinafter directed in Holy Trinity Churchyard, Clandown, in the County of Avon, has, in pursuance of an Order in Council made the 26th day of July 1979 and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section 1 of the Burial Act 1853 (1853 c. 134), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

1. Burials shall be discontinued forthwith in Holy Trinity Churchyard, Clandown, in the County of Avon.

Provided that—

(a) in any vault or walled grave now existing in the said Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stone-work or brickwork properly cemented;

(b) in any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any
