Whereas it is expedient to make provision for the abatement of retired pay awarded to Retired Officers of the Royal Navy and Royal Marines employed by the Royal Navy and Royal Marine, Army, or Royal Air Force Sports Control Boards:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by Section 3 of the Naval and Marine Pay and Pensions Act 1865(a) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. This Order shall come into operation on 1st January 1980 and may be cited as the Naval and Marine Pay and Pensions (Retired Officers' Abatement) (Amendment) Order 1979.

2. The Naval and Marine Pay and Pensions (Retired Officers' Abatement) Order 1975 shall be amended, in the Schedule thereto, by deleting the heading and opening paragraph and substituting the following:

*"Retired Officers employed by the Ministry of Defence or by the Royal Navy and Royal Marine, Army or Royal Air Force Sports Control Boards—Abatement of Retired Pay.*

(1) An Officer in receipt of retired pay shall, for so long as he is employed by the Ministry of Defence as a Principal Retired Officer or Retired Officer Grade I, II or III, have his service retired pay abated in accordance with the following scales and subject to such instructions as may be published from time to time by the Defence Council.

(2) An Officer in receipt of retired pay shall, for so long as he is employed by the Royal Navy and Royal Marine Sports Control Board, the Army Sports Control Board or the Royal Air Force Sports Control Board on rates of pay in line with those paid to the Retired Officer Grades in the Ministry of Defence, have his retired pay similarly abated."

### TENDERS FOR TREASURY BILLS

1. 3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000 and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Tenders must be made on the printed forms which may be obtained from the Bank of England.
