Y SWYDDFA GYMREIG HIGHWAYS ACTS 1959 TO 1971

The Fishguard-Bangor (Menai Suspension Bridge) Trunk Road (Afon Soden Improvement) Order 1979 and The Fishguard-Bangor (Menai Suspension Bridge) Trunk Road (Afon Soden Improvement Side Roads) Order 1979

The Secretary of State for Wales hereby gives notice that in relation to the above-mentioned Trunk Road at Synod Inn in the County of Dyfed, he has made under the Highways Act 1959:

- an Order under section 7 which provides that a road which he proposes to construct at Synod Inn, in the County of Dyfed shall become a trunk road as from the date when the Order comes into operation and
- an Order under section 9 of the Highways Act 1959 authorising him
 - to improve, raise, lower or otherwise alter highways.
 - (b) to stop up highways,
 - (c) to construct a new highway (which will be a footpath) to connect footpath 51/73 with the above-mentioned Trunk Road,
 - (d) to stop up private means of access to premises, and
- (e) to provide a new means of access to premises, all at Synod Inn aforesaid, and to provide for the transfer of the said new highway to the County Council of Dyfed as from the date on which he notifies the Council that the new highway has been completed.

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959 or the Highways Act 1971 or on the ground that any requirement of either of those Acts, or of regulations made thereunder, has not been complied with in relation to the Orders, may within six weeks from 3rd December 1979 apply to the High Court for the suspension or quashing of the Orders or Court for the suspension or quashing of the Orders or of any provision contained therein.
