(a) In respect of the proposed new metered parking places set out in paragraphs 2 (b) and (c) above the hours of operation would be 8.30 a.m. to 6.30 p.m. on Mondays to Fridays inclusive and 8.30 a.m. to 1.30 p.m. on Saturdays (Christmas Day, Good Friday and Bank Holidays excepted). The vehicles that may be left in the metered parking places are passenger and Bank Holidays excepted).
