TOWN AND COUNTRY PLANNING ACT 1971

The Minister of Transport hereby gives notice that on the application of Chorley Borough Council he has made an Order under section 209 of the above Act entitled "The Stopping up of Highways (County of Lancashire) (No. 1) Order 1980" authorising the stopping up of parts of Water Street and Hollinshead Street, Chorley to enable the extension and change of use of 1-3 Hollinshead Street into a public house, restaurant and staff accommodation and the provision of a car park and associated landscaping to be carried out in accordance with planning permission granted to C.
