- (b) to compel vehicular traffic proceeding in

 (i) the carriageway on the west side of the southernmost island site situated at or adjacent to the junction of Brookfield Road, Cassland Road, Kenworthy Road and Wick Road either to proceed into Kenworthy Road or to turn

 left into Wick Road;
 - (ii) the carriageway on the east side of the above-mentioned island site to turn right into Wick Road.

3. The requirements referred to in paragraph 2(b) above will not apply in respect of anything done with the permission or at the direction of a police constable in uniform.

The Havering (Prescribed Routes) (No. 1) Traffic Order 1980 Notice is hereby given that the Greater London Council on 25th January 1980 made the above-mentioned Order under section 6 of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Order will be to prohibit vehicles the overall width of which together with the load (if any) carried thereon exceeds seven feet from using Spring Gardens, Romford as a through route, by the placing of obstructions in Spring Gardens 49 feet south-east of the south-eastern kerb-line of Jubilee Avenue.

3. Exemption has been provided in the Order

(a) for vehicles being used for ambulance, fire brigade or police purposes in certain circumstances;

- (b) in respect of anything done;
 - (i) with the permission or at the direction of a police constable in uniform;
 - (ii) in accordance with any restriction or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

The Hillingdon (Waiting and Loading Restriction) (Amendment No.) Order 1980

Notice is hereby given that the Greater London Council propose to make the above-mentioned Order under sections 6 and 84D of the Road Traffic Regulation Act 1967, as amended by the Transport Act 1968 and the Road Traffic Act 1974.

2. The general effect of the Order would be further to amend the Hillingdon (Waiting and Loading Restriction) Order 1978, so that in the lengths of street specified in the Schedule to this Notice:

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited between 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place would be prohibited between 11 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive;
- (c) the sale or offer for sale of goods from a vehicle would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Hillingdon Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, would be prohibited.

3. The prohibitions referred to in paragraph 2(a) and (b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform or in certain circumstances, e.g., the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc. The usual exemption relating to vehicles displaying a disabled person's "Orange Badge" would apply.

4.
