The Secretary of State for Wales in relation to Wales and the Minister of Transport in relation to England hereby give notice that they propose to make the following Orders:

- an Order under Section 7 of the Highways Act 1959 providing:
  - a. that a road about 10.81 kilometers in length which they propose to construct between the Wrexham they propose to construct between the Wrexham By-Pass and the Chester Southerly By-Pass in the Counties of Clwyd and Cheshire shall become a trunk road as from the date when the Order comes into operation, and
  - b. that the length of the Swansea-Manchester Trunk Road to be superseded shall cease to be a trunk road as from the date on which notice is given by them to the County Councils of Clwyd and Cheshire (who will become the highway authorities responsible for those lengths lying within Wales and England respectively) that the Gresford-Pulford By-Pass is open for through traffic, and
- an Order under Section 9 of the Highways Act 1959 authorising them:
  - a. to improve, raise, lower or otherwise alter highways,
  - b. to stop up highways,
  - c. to construct new highways,
  - d. to stop up private means of access to premises, and
  - e. to provide new means of access to premises,

all between the Gresford Interchange of the Wrexham By-Pass in the County of Clwyd and a point on the A483

Swansea-Manchester Trunk Road between the junctions of Rake Lane and Balderton Road in the County of Cheshire and providing for the transfer of each of the said new highway to the highway authority specified therefor in the Order as from the date on which they respectively notify that authority that the new highways have been completed and are open for through traffic. new highway authority specified therefor in the Order as from the date on which they respectively notify that authority that the new highways have been completed and are open for through traffic.
