The QUEEN has been graciously pleased, on the advice of Her Majesty's Fiji Ministers, to approve the award of the Military Medal in recognition of services with the Fiji Infantry Regiment serving in the Lebanon as part of the United Nations Peace-keeping Force.

Military Medal Sergeant Sikaba Nabitalai Suwai (21391), Fiji Infantry

Regiment.
On 16th August 1979 Sergeant Suwai was in command of 5 Platoon, B Company, 1st Battalion, Fiji Infantry Regiment. His platoon was occupying a check point in the area of Aitit, South Lebanon. A group of six soldiers had recently left the check point on a physical training run. At 9 a.m. shots were heard coming from the direction the party had taken. The firing was of such intensity that Sgt. Suwai immediately calculated that the group of runners was in trouble. He assembled five other soldiers and a vehicle and rushed towards the area of the shooting. The area was entirely open and dominated by a hill from which the fire was coming. One soldier was lying beside the road critically wounded while the remainder of the group were using what cover was available and returning fire. Sgt. Suwai took immediate command and from a position completely exposed to the hostile fire, directed the evacuation of the wounded soldier. At the same time he skilfully directed the fire of the group at the enemy so the possibility of further casualties was minimized.

Sergeant Suwai appreciated the most effective way to extricate his group from the direct enemy fire was to attack the enemy's position. This involved an assault up a steep slope devoid of cover and with minimum protection. Demonstrating considerable aggression and command skill, Sgt. Suwai led the assault under continuous fire from the hilltop. This objective was secured without further casualties demonstrating the skill with which it was controlled.

The enemy retreated from the hill and commenced firing at the group from a further position in a nearby wadi. Once again Sgt. Suwai ordered this objective assaulted, leading and directing the attack personally. As a direct result of Sgt. Suwai's initiative, courage and decisive leadership four hostile armed elements were captured with their weapons. That further casualties were avoided is further testimony of the skill and daring demonstrated by Sergeant Suwai whose actions accorded with the highest infantry traditions.
