Lisbonne, May 29. The 26th instant the Heer Oxenstern had his Audience from the Prince, in order to his departure, intending to embark on board Sir Edward Sprage, who is to Convoy several ships bound for England as far as the Northern Cape, and then to go on board an Hamburger bound for Zealand.

The Loretto, a great Genouese vessel is gone to Oporto to bring about the new Portuguese Gallion that has been some years building; two others ships are here fitting up, which with the said Gallion are to guard the Coasts from the Turks at the return of the Brazile Fleet.

Vienna, June 15. The Prince Ragotski has upon the endeavors of the Princess his Mother, submitted himself to the Emperor and obtained his pardon, which has prevailed with the Rebels in the 13 Counties to lay down their Arms and make their submissions: the young Prince seems to have been inveigled into this conspiracy by the enemies of the Empire, all whose subtle practices may be now detected, which tis believed had the same Authors, and were carried on by the same power which endeavoured also to involve Poland at the same time in new disturbances.

The young Prince is contented that two Garifons of the German forces shall be entertained within his Lordships; he engages to pay the Emperor a considerable sum of Moneys, to assist the Emperor with his forces, and to deliver into his hand the principal Authors and Fomenters of the late troubles; with the original Papers of the whole conspiracy.

The Imperial Army is about Eperies and Cassovia, where still the people much scruple the receiving of German Garifons. General Spork had intelligence of 5000 Hungarian Horse which were in the Field with an intention to attempt upon him, but he drawing up his forces and preparing to Charge them, they retired, and since sent some Commissioners to the General to assure him of their willingness to submit themselves to the Emperor as their Sovereign Lord and Prince.

We have by a later advice received the news that both

both *Eperies* and *Casovic* have been content to take in an Imperial Garrison, but that several of the rebellious Troops are retired towards *Transylvania* and other parts of the Turkish Dominions.

*Genova*, June 18. The 14th Instant arrived here one of the Great Dukes Gallies from *Palermo* with many Bales of Silk for this place, and the same day put to sea again for *Legorn*, whither sailed yesterday the Dutch Convoy of two men of war and 6 Merchant ships. The same day sailed the *Return for Zante* and will in few days be followed by the *Conclusion*.

From *Milan* we are told that the Duke d' *Ossuna* the new Governor, having notice of the arrival of the Prince de *Ligne* upon the frontiers, sent two Companies of his Guards to receive him at *Cremuz*, who attended him to *Lody*, the first City belonging to the Dutchy of *Milan*, where the said Prince was introduced with extraordinary honour by the Bishop of that City, the Prince *Trivulzio* and several persons of Quality, with a Train of above 20 Coaches with 6 horses, the Canons discharged, and several Volleys given him by the Foot Companies, he was honourably entertained at the Bishops Palace where he was complimented by a Gentleman sent by the Governour, which the Prince returned by one of his own Gentlemen. The Marquis de *los Balbes* Spain gave and received from him a visit, after which the Prince took his way by *Castel Nuovo* towards *Genova*.

The Prince de *Ligne* is lately arrived here and remains in *o. i. o.*, residing a Palace prepared for him in this City; five of the Gallies which attend for his Transportation, have been taking in soldiers at *Finale*, and are returned thence this morning. On Saturday the Prince intends (if not sooner) to embark and set forwards towards his Vice-Royalty of *Sicily*.

*Hambourg*, June 20. As yet the business of *Regenstein* is not past the dispute, the right to the place being still under consideration of the Mediators who endeavor, if possible, to satisfy all parties concerned, and to prevent the breach of the publick peace which was hereby much endangered; the forces on each side during the months truce agreed upon between them, keep within their Quarters, their Officers being ordered to forbear all hostilities till some effect appear of the Arbitration.

The *Lorrain* forces continue about *Erfort*, and the Countrey called *Eisfeldt*, being ready to be employed by his Imperial Majesty, whose affairs should require their assistance.

Some late Letters from *Vienna* tell us, that the disturbances in *Hungary* are not yet compos'd; the inhabitants of the *Upper Hungary* being infinitely displeas'd at the procedure of the Imperial forces, inasmuch, as they have drawn a considerable strength together, intending to stand upon their Guard.

The Diet at *Ratisbonne* is now debating the differences between the House of *Nassau* and the Duke of *Lorrain*, the latter being unwilling to make restitution of the Lands belonging to the former, till the Money is paid for which they are engag'd.

They are also considering how to regulate Coins.

The Comte d' *Oeting* has been complain'd of in the Assembly, that being a Protestant he refuses to permit the Roman Catholicks to have a free exercise of their Religion within his jurisdiction, where he pretends to a Spiritual as well as a Temporal power, in which the Comte defends himself, urging the like methods used by the Roman Catholicks against the Protestants.

*Brussels*, June 27. His Excellency the Constable of *Castille* finding some indisposition of body, keeps himself retired, leaving all affairs to his Secretary, who this week received my Lord *Castlehaven* on his

return from *England* to the Command of his Regiment.

The Adjutant-General of *Battalia* being ordered to arrest one Baron *Butler*, an Irish Captain of Horse for having forcibly released some of his soldiers imprison'd by the Governours Command; the said Adjutant mistaking the name, seized on Captain *Porter* on Tuesday last in the Park at *Brussels*, and was conveying him to the Castle of *Vilvoord*, but notice being presently taken of the mistake, the Duke de *Villa Hermosa*, the General of the Horse, immediately sent away a Post, who called back Captain *Porter* on the midway to *Vilvoord*, whom the Duke himself was pleas'd to visit at his Lodging with Don *Antonio de Cordoua* his Lieutenant-General, to excuse the error of the Adjutant, whom he order'd to be discharged his employment, and imprison'd, but pardon'd him upon the intercession of the said Captain *Porter*.

The same Tuesday night happened a fire in the street leading from the Jesuits Church to the Stone Port, by the accidental falling of a Squib into a Hay-loft, which in little time burnt down 11 or 12 Houses, and amongst others a very fair new house of the Count de *Brouay*.

The Constables Baggage is carried to *Ostend*, himself impatiently expecting the return of every Courier for his dismission from the Government of these Provinces. He intending as soon as may be to depart hence by the way of *France* into *Spain*.

The Horse continue their Quarters as formerly between this City, *Malines*, and *Louvain*, to the great trouble of the Countrey; the Deputies of the Province of *Brabant* are endeavouring to have them removed into *Luxembourg*, *Limbours*, and *Queldres*, but as yet without effect.

A Courier newly arrived from *Spain* tells us, that as yet no Governor is appointed to succeed the Constable of *Castille* in these Provinces. Don *John of Austria* has been press'd to accept of it, but he excuses himself; others have negotiated for the Prince of *Lorrain*, but as yet nothing is resolv'd.

*London*, June 26. On Friday the 24th Instant His Excellency Monsieur *Colbert* the French Ambassador, had an Audience from their Majesties with the usual Ceremonies, condoling for the death of Madam, making afterwards his Compliments upon the same account to their Royal Highnesses. The Marshal de *Bellefonds* is also on his way hither, to Complement their Majesties and Royal Highnesses in a more solemn manner, in the name of His most Christian Majesty.

This day the *Venetian* Ambassador and the Dutch Minister, made also their Compliments to their Majesties and Royal Highnesses upon the same subject.
