- 16. Uniting the benefices of Gosberton Clough; and Quadring, in the diocese of Lincoln.
- 17. Uniting the benefices and parishes of Bardney and Minting, in the diocese of Lincoln.
- 18. Establishing a team ministry for the area of the benefice of Saint Michael, Chell, in the diocese of Lichfield.
- (1) Dissolving the benefice of East Runcorn with Halton and its team ministry;
 - (2) creating new benefices and parishes of Saint Mary, Halton; Saint Andrew, Grange; Saint Mark, Hallwood; Saint Berteline and Saint Christopher, Norton; and Holy Trinity, Runcorn; and
 - (3) altering the areas of the parishes of East Runcorn with Halton; Saint John, Weston, Runcorn; Saint Michael and All Angels, Runcorn; Runcorn; and Aston, in the diocese of Chester.
- 20. Establishing a team ministry for the area of the benefice of Tettenhall Regis, in the diocese of Lichfield.
- 21. Providing for the demolition of the redundant parish church of the former parish of Saint Lawrence, Byker, in the diocese of Newcastle, and empowering the said Commissioners to sell its site and the land annexed or belonging thereto.
- 22. Uniting the benefice of Thorncombe in the diocese of Salisbury and the benefice of Winsham with Cricket Saint Thomas, in the diocese of Bath and Wells.
- Uniting the benefices of Woburn; Eversholt with Milton Bryan; and Battlesden with Pottesgrove, in the diocese of Saint Albans.
- 24. Uniting the benefices of Collierley and Saint Aidan, Annfield Plain, in the diocese of Durham.
- 25. Appropriating the redundant church of Saint Mary, Thetford, a former parish church of the parish of Thetford, in the diocese of Norwich, to use for worship, services and other activities of a religious nature in accordance with the rites and customs of the Roman Catholic Church and for purposes ancillary thereto; and empowering the Norwich Diocesan Board of Finance to lease the said building for such uses.
- 26. Appropriating the redundant parish church of the parish of Saint Jude, East Brixton, in the diocese of Southwark, and the land annexed or belonging thereto to use as a furniture store and for purposes ancillary thereto, and empowering the said Commissioners to sell the said building and land for such uses.
- 27. Uniting the benefices of Cranborne cum Boveridge; Edmondsham; Wimborne Saint Giles; and The Ascension, Woodlands, in the diocese of Salisbury, and altering the name of the parish of Cranborne.
- 28. Appropriating the redundant church of Saint Peter, Culford Heath, in the diocese of Saint Edmundsbury and Ipswich, and the land annexed or belonging thereto, to use for social purposes, and for religious purposes in accordance with the rites and customs of the Roman Catholic Church; and empowering the said Commissioners to sell the said building land and for such uses.
- 29. Amending the provisions of an earlier Scheme which provided for the appropriation and disposal of parts of the land annexed or belonging to the redundant church of Saint Mary the Virgin, Stony Stratford, in the diocese of Oxford, for parsonage and parochial purposes.
- 30. Uniting the benefices and parishes of Saint Wilfrid, Harrogate; and Saint Luke, Harrogate, in the diocese of Ripon, and declaring redundant the parish church of the parish of Saint Luke, Harrogate.
- 31. (1) Revoking certain provisions of an earlier Scheme;
 - (2) appropriating the redundant church of Saint Edmund, Norwich, in the diocese of Norwich, to use for any civic, public or educational purpose or for storage;
 - (3) appropriating the land annexed or belonging to the redundant church for purposes ancillary to the use of the building and for car-parking; and

- (4) empowering the said Commissioners to give the said building and land for such uses.
- 32. Uniting the benefices of Upper Langwith; and Saint Luke, Whaley Thorns, in the diocese of Derby.
- 33. Appropriating the old church tower, Upton-on-Severn, in the diocese of Worcester, and the land annexed or belonging thereto, to use as a heritage and information centre and for other community purposes and empowering the said Commissioners to give the said building and land for such uses.
- 34. Appropriating the redundant church of Saint John the Baptist, one of the parish churches of the parish of Portsea All Saints with Saint John the Baptist, Rudmore, in the diocese of Portsmouth, and the land annexed or belonging thereto, to use for office purposes and for purposes ancillary thereto; and empowering the said Commissioners to sell the said building and land for such uses.
- 35. Uniting the benefices and parishes of Saint Dunstan, East Acton and Saint Thomas, Acton Vale, in the diocese of London; and declaring redundant the parish church of the parish of Saint Thomas, Acton Vale.
- 36. Establishing a team ministry for the area of the benefice of Saint Francis, Westborough, Guildford, and altering the areas of the parishes of Saint Francis, Westborough, Guildford; All Saints, Guildford, and Worplesdon, in the diocese of Guildford.
- 37. (1) Uniting the benefices of Saint Andrew and Saint Peter, Drypool (otherwise known as Saint Columba with Saint Andrew and Saint Peter, Drypool); Saint John Drypool; and Saint Saviour and Saint Mark, Wilmington, Kingston upon Hull;
 - (2) uniting the parishes of Saint Columba with Saint Andrew and Saint Peter, Drypool; Saint John, Drypool; and Saint Saviour and Saint Mark, Wilmington, Kingston upon Hull;
 - (3) establishing a team ministry for the area of the new benefice;
 - (4) declaring redundant the parish church of the parish of Saint Saviour and Saint Mark, Wilmington, Kingston upon Hull, and
 - (5) altering the areas of the parishes of Saint Saviour and Saint Mark, Wilmington, Kingston upon Hull; and Sutton, Saint James, in the diocese of York.
- 38. (1) Providing a new place of worship within the parish of Saint Paul, Brixton, in the diocese of Southwark;
 - (2) declaring redundant the existing parish church of the said parish;
 - (3) appropriating the redundant old church and the land annexed or belonging thereto, to use for worship, services and other activities of a religious nature in accordance with the rites and customs of the Seventh Day Adventist Church and for purposes ancillary thereto; and
 - (4) empowering the said Commissioners to exchange the said building and land for such uses.
- 39. Creating a new benefice of Hoo, and altering the names of the benefice of East Dereham with Hoo, and the parish of Hoo, in the diocese of Norwich.
- 40. In substitution for a Scheme confirmed by Her Majesty in Council on the 19th October 1979 for uniting the benefices of Cattistock with Chilfrome and Rampisham with Wraxall; Corscombe; Evershot, Frome Saint Quinton, Melbury Bubb and Melbury Osmond with Melbury Sampford; and Halstock and The Chelboroughs, in the diocese of Salisbury, and establishing a team ministry for the area of the new benefice.
- 41. Uniting the benefices of Bellingham and Thorneyburn with Greystead; Corsenside; Falstone; and Otterburn with Elsdon and Horsley with Byrness, in the diocese of Newcastle, and establishing a team ministry for the area of the new benefice.
