### TREASURY SOLICITOR

REDWOOD ESTATES LIMITED (DISSOLVED)

*Notice of Disclaimer Under Section 355  
of the Companies Act 1948*

Whereas:

(1) Pursuant to section 353 (5) of the Companies Act 1948 Redwood Estates Limited (hereinafter called "the Company") became dissolved on 30th August 1979.

(2) It is alleged that immediately before such dissolution the property disclaimed by this Notice was vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

(3) It is desired to disclaim the Crown's Title (if any) to the property.

(4) That the property may have vested came to the notice of the Treasury Solicitor on the 22nd January 1980.

Now therefore I, the Treasury Solicitor, in exercise of the power in that behalf given by section 355 of the Companies Act 1948 do by this notice disclaim the Crown's title (if any) to the property described in the Schedule hereto.

#### THE SCHEDULE

##### *Property Disclaimed*

The ninety-nine year Lease made 28th June 1968 between West Sussex County Council (the Landlords) and John Dennis Chipperfield (the Tenant) of all that parcel of land situate on the north side of Beach Green, Shoreham-by-Sea, being Plot No. D.338 on the Landlord's Estate Plan for Shoreham Beach which said Lease was assigned by the Tenant to the Company on 24th April 1972.

4401/180 (COM (79) 784). Proposal for a Council Directive amending Directive 71/118/EEC as regards medical examination of personnel engaged in the production of poultrymeat.

4476/80 (COM (79) 788). Proposal for a Council Regulation (EEC) amending Council Regulation (EEC) No. 3179/78 concerning the conclusion by the European Economic Community of the Convention on Future Multilateral Co-operation in the North-west Atlantic Fisheries.

4460/80 (COM (79) 793). Proposal for a multilannual Community Programme of research and development in bimolecular engineering (indirect action 1981-85).

4475/80 (COM (79) 787). Proposal for a Council Regulation (EEC) concerning allocation and control of certain catch quotas for vessels flying the flag of a Member State and fishing in the Regulatory Area defined in the NAFO Convention.

4481/80 (COM (80) 25). Proposal for a Council Regulation concerning, for certain fish stocks, occurring in the Community fishing zone, the fixing for 1980 of the total allowable catches and the means of making the catches, together with the share available for the Community.

Proposal for a Council Directive amending for the fourth time Council Directive 76/769/EEC on the approximation of the laws, regulations and administrative provisions of the Member States relating to restrictions on the marketing and use of certain dangerous substances and preparations.
