Whereas it is expedient to provide for the award of pen-sions to the widows of Non-Commissioned Officers and Men of the Royal Navy and Royal Marines who are not at present eligible for a pension solely because of their

husband's rank or rating: Now, therefore, Her Majesty, in exercise of the powers conferred upon Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (1865 c. 73), and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered as follows: ordered, as follows:

Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Special Widows' Pensions) Order 1980.

Interpretation

2. A "special widow's pension" means a pension awarded to a widow who is ineligible for a Forces Family Pension because of the provisions of Clause 15 of Section III of Schedule VIII of Order in Council of 14th March 1979.

General

- 3. The rates and conditions of award of a special widow's pension in respect of a husband's service in the Royal Navy and Royal Marines shall be as specified in the Schedule attached thereto.
- 4. Except as otherwise indicated the provisions contained in the Schedule to this Order shall have effect from 12th November 1979.

SCHEDULE 1. The special widows' pensions provided for in this Schedule are pensions payable on application in respect or the service of requisite length of deceased Chief Petty Officers, Petty Officers, Non-Commissioned Officers and Men of the Royal Navy and Royal Marines (including those given temporary promotion to commissioned or war-rant rank during the 1939 to 1945 War) and hereinafter referred to as "ratings". They are not payable in respect of deaths attributable to service. Eligibility

- 2. To be eligible for the award of a pension under this Schedule the following conditions must be fulfilled:
  - (a) The rating in respect of whose service the claim is made was in receipt of, or was eligible for, a service pension or invaliding pension determined by reference to his length of service; or, if his death occurred while serving, an invaliding pension would have been payable had he been invalided on the day of his death.
  - (b) The applicant is not in receipt of a Forces Family Pension or a War Widow's Pension.
  - (c) The applicant married the rating in respect of whose service her claim is made before his discharge from the Service, or, if he subsequently gave further ser-vice in circumstances rendering him eligible to be considered for a re-assessment of service pension, before the termination of such further service.
  - (d) The applicant did not remarry subsequent to the death of the rating in respect of whose service a pension is claimed. If, however, such a remarriage has come to an end an award may be made at the discretion of the Secretary of State for Defence in the light of the circumstances of the case.
  - (e) The applicant is not living with a man as his wife.

#### General Conditions Governing the Award of a Special Widow's Pension

3. An award of pension to a widow who is, or was, separated from her husband at the date of his death will be at the discretion of the Secretary of State for Defence who may withhold all of, or such a proportion of, the pension as seems appropriate in all the circumstances of the case.

4. If the death of the husband was due wholly or in part to his own negligence or misconduct or to any cause within his own control, the award and amount of any special widow's pension payable shall be at the discretion of the Secretary of State for Defence.

- 5-(a) Where the deceased husband has suffered any abatement of pension on account of his misconduct or inefficiency such abatement may be ignored when assessing the pension payable to the widow under this Schedule, except as provided for in sub-clause (b) below.
- below.
  (b) Where the Secretary of State for Defence is of the opinion that the misconduct of the applicant's husband constitutes a grave offence against the State as defined in Clause 14 of the Schedule to Order in Council 9\*/NPP of 25th July 1978, and he is satisfied that the applicant wilfully aided and abetted the commission of that offence he may wish in his discretion direct that any pension payable to the widow may be abated by such amourt as seems to him appropriate having regard to all the circumstances of the case.

6. In exceptional circumstances the Secretary of State for Defence may at his discretion withhold a part of a pension granted under this Schedule and may divert such pension in whole or in part for purposes which he may deem beneficial to the pensioner.

7. If the applicant is granted any other pension or allow-ance from public funds payable by virtue of the deceased husband's service in the Royal Navy or Royal Marines, then the Secretary of State for Defence may at his dis-cretion withheid or reduce any award otherwise admissible.

8. The pension of a widow will cease of she remarries or lives with a man at his wife after the award of the pension, but if the matriage or living with a man as his wife cornes to an end polore her death per pension may be restored in whole of in part at the discretion of the Secretary of State for Defence.

9. If the death of the rating in respect of whose service the ponsion is claimed occurred within a year of the applicant's marriage to him, the Secretary of State for Defence may reduce or withhold the amount of any award otherwise admissible.

10. If a widow dics before claiming a pension, arrears of pension will not, sive in exceptional circumstances, be allowed to her estate.

#### Date of Commencement

11. The date of commencement of a special widow's pension will be 12th November 1979 or the day following the date of the husband's death if later, provided that application is not unduly delayed.

## Rates of Pension

12. Widows eligible for the award of a special widow's pension may be awarded a pension at the weekly rates shown below appropriate to the rank of the rating in respect of whose service her claim is made. The rating's rank for this purpose will be the highest paid rank held by him for two years or more in his last five years of service, unless he was invalided or died in service when it will be the substantive rank held at the time of discharge or death.

13. The rates of pension set out in Clause 12 above will be increased annually from November 1980 onwards in line with the increases provided for minimum rates of Forces Family Pensions under Pensions Increase Orders in Council. The increased rates will be rounded to the nearest new penny.



- (c) prohibit the landing in Great Britain from certain countries of specified trees and isolated bark (article 6 and Schedule 3), (article 4 of the Directive);
- (d) set out the conditions under which other specified trees and isolated bark and certain wood and soil are permitted to be landed in Great Britain (article 7 and Schedule 4), (article 5 of the Directive);
- (e) set out the circumstances in which specified trees, wood, isolated bark and soil are to be accompanied by phytosanitary certificates, reforwarding phytosanitary certificates or certificates of origin when landed in Great Britain, the form of such certificates and require-ments as to their completion (articles 8, 9, 10 and 12 and Schedules 5, 6 and 8), (articles 4, 5, 6, 7, 8, 9 and 12 of the Direction). 12 of the Directive);

- (h) provide that officers of Customs and Excise may detain imported trees, wood, isolated bark or soil for examination by an inspector (article 17);
- (i) provide that the landing in Great Britain of any tree, wood, isolated bark, soil, tree pest or genetically mani-pulated material the landing of which is prohibited by this Order, may be authorised by licence (article 18), (article 14 of the Directive);

(j) require that persons having in their possession information regarding any tree, wood, isolated bark, tree pest or genetically manipulated material landed in Great Britain or exported therefrom may be required to disclose that information (article 19);

(k) provide for offences in connection with the Order and lay down penalties for contraventions (article 21).
