PASTORAL MEASURE 1968

Notice is hereby given that Her Majesty was pleased on the 21st April 1980 by Order in Council to confirm the following Schemes made by the Church Commissioners for:

1. Uniting the benefices of Over and Nether Compton, Trent and Sandford Orcas; and Oborne with Poyntington, in the diocese of Salisbury.

2. Uniting the benefices of Hopton and Corton, in the diocese of Norwich.

3. Uniting the benefices of Attleborough (otherwise known as Attilborough Major with Attilborough Minor), and Besthorpe, in the diocese of Norwich.

4. Uniting the benefices of Collingtree with Courteenhall; and Milton Malsor (otherwise known as Middleton Malgor) in the diocese of Peterborough.

5. Appropriating part of the churchyard of the parish church of the parish of Saint Paul with Saint Barnabas, Bristol, in the diocese of Bristol, as an addition to the parsonage land of the benefices of the same name.

6. Uniting the benefices of Wilshamstead (otherwise Wilstead) and Houghton Conquest with Houghton Gildaple; and altering the names of the parishes of Wilshamstead (otherwise Wilstead) and Houghton Conquest with Houghton Gildaple, in the diocese of Saint Albans.

7. Uniting the benefices of Pembridge and Shobdon and altering the name of the parish of Pembridge, in the diocese of Hereford.

8. Uniting the benefices of Somerton; and Compton Dundon, in the diocese of Bath and Wells.

9. Establishing a team ministry for the area of the benefice of Ribbleton, in the diocese of Blackburn.

10. Uniting the benefices of Barton-le-Cley with Higham Gobion : and Hexton, and altering the areas of the parishes

of Higham Gobion and Barton-le-Cley, in the diocese of Saint Albans.

11. Creating a new benefice and parish of Estover out of parts of the parishes of Egg Buckland; and Saint Mary the Virgin, Laira, in the diocese of Exeter.

12. Uniting the benefices of Charlton Musgrove; and Cucklington with Stoke Trister, in the diocese of Bath and Wells.

13. Transferring part of the parish of Little Stanmore (or Whitchurch), in the diocese of London, to the parish of Elstree, in the diocese of Saint Albans.

14. Declaring redundant the parish church of the parish of Cross Stone, in the diocese of Wakefield.

15. Uniting the benefices of Hope and Castleton, in the diocese of Derby.

16. Uniting the benefices of Preston in Holderness; and Sproatley, in the diocese of York.

17. Uniting the benefice of Rye, Rye Harbour and Playden and Iden; and the benefice of Camber and East Guldeford, in the diocese of Chichester, and establishing a team ministry for the area of the new benefice.

18. Uniting the benefices and parishes of Saint Alban, Golders Green, and Saint Michael, Golders Green in the diocese of London, and declaring redundant the parish church of the parish of Saint Michael, Golders Green.

19. Uniting the benfices and parishes of Graffoe and Skinnand, in the diocese of Lincoln.

20. Creating a new benefice and parish of Newton Hall out of part of the parish of Saint Cuthbert, Durham, in the diocese of Durham.

21. Altering the name of the parish of Stillingfleet and uniting the benefices of Escrick; and Stillingfleet with Naburn, in the diocese of York.

22. Declaring redundant the church of Saint Oswald Collyhurst, being the parish church of the parish of The Saviour, Collyhurst, in the diocese of Manchester.

23. Uniting the benefices and parishes of Newark-upon-Trent (Saint Mary Magdalene); Saint Lenard, Newarkupon-Trent: Christ Church, Newark-upon-Trent; Hawton; Cotham and Shelton, in the diocese of Southwell, and establishing a team ministry for the area of the new benefice.

24. (1) Providing for a new place of worship within the parish of East Ham with Saint Alban, Upton Park, in the diocese of Chelmsford;
