THE CLEAN AIR ACT 1956

The Borough Council of Gateshead (No. 14 Smoke Control (Variation) Order 1980

Notice is hereby given that the Borough Council of Gateshead in exercise of the powers conferred on them by section 11 (5) of the Clean Air Act 1956 on 25th April 1980, made an Order entitled "The Borough Council of Gateshead (No. 14) Smoke Control (Variation) Order 1980" which varies "The Borough Council of Gateshead (No. 14) Smoke Control Order 1979" by providing for the exemption of the buildings specified in the Schedule hereto from the operation of section 11 of the Clean Air Act 1956 so that the emission of smoke from a chimney of these buildings is not an offence.

If confirmed the Order will come into operation on the date of its confirmation or such later date as may be determined by the Secretary of State for the Environment.
