COVENTRY CITY COUNCIL

City of Coventry (Broadgate Area) (Prohibition of Driving) Order 1980

Notice is hereby given that pursuant to the powers delegated to them by the West Midlands County Council under section 101 of the Local Government Act 1972, and with the consent of the Minister of Transport, Coventry City Council have made the above-mentioned Order, under section 1 of the Road Traffic Regulation Act 1967, as amended, which will come into operation on 20th May 1980.

- (iii) for fire brigade, ambulance or police purposes in emergency circumstances;
- (iv) as a public service vehicle, a licensed hackney carriage or private hire vehicle;
- (v) by a funeral director or owner of funeral vehicles when in use as part of a funeral cortege or otherwise in connection with a funeral, or by the owners of wedding vehicles when in use in connection with a wedding, or by a disabled person;
- (vi) to transport goods to or from premises fronting onto the roads or lengths of roads mentioned in the schedule below or to premises at the northern end of Hertford Street not having a rear or other access;
- (vii) for access or off street garages and car parking areas adjoining the roads or lengths of roads mentioned in the schedule below.

Notice is hereby given that the Council of the London Borough of Ealing propose to make an Order under section 31 (1) of the Road Traffic Regulation Act 1967, as amended by subsequent Acts, to vary the provisions of the existing Orders which govern off street car parking both in multi-storey and surface car parks.

I. *Multi Storey car parks at Springbridge Road, W.5 and Talbot Road, W.13:*

Increased charges: Mondays to Saturdays for any period not exceeding 2 hours—10p, for each additional hour or part thereof—10p; "out of hours" fixed charge—30p.

Season tickets: to become available at £100 plus VAT per annum.

The car parks will continue to remain open from 0700 to 1900 (2100 Fridays), closed Sundays and Bank Holidays. The maximum permitted stay remains 24 hours and use of the car parks remains restricted to vehicles not exceeding 2½ tons in weight or 6 feet 6 inches in height.

II. *Surface car parks:*

(a) Alfred Road car park W.13 will become known as Singapore Road car park. It will continue to remain open all hours all week to vehicles not exceeding 2½ tons in weight or 6 feet 6 inches in height. Charges will continue to be payable on a pay and display basis from 0700 to 1900 (2100 Fridays); all other times, Sundays and Bank Holidays—free. Charges are increased to 20p for any period not exceeding 2 hours and the maximum permitted stay is reduced to 2 hours with return prohibited within 1 hour of leaving.

(b) Oldfield Lane car park, Greenford, will become known as Greenford Broadway car park. That car park, together with those at Steyne Road, W.3 (opposite Narrow Street), George Street, W.7, Norwood Road, Southall (rear of Black Dog P.H.), Norwood Road, Southall (site of Nos. 15-17) and Featherstone Road, Southall, will continue to remain open all hours all week to vehicles not exceeding 2½ tons in weight or 6 feet 6 inches in height. In all of these charges are to be introduced on a pay and display basis from 0900 to 1730 (1900 Fridays); all other times, Sundays and Bank Holidays—free. Charges will be 10p per hour or part thereof and the maximum permitted stay remains 24 hours. Featherstone Road car park will also remain open to all vehicles from 0000 to 0700 and 1900 to 2400 Monday to Saturday and all day Sunday at no charge.

(c) The car park in Uxbridge Road, W.13 (by Dean Gardens), continues to be open all hours all week to vehicles not exceeding 2½ tons in weight or 6 feet 6 inches in height and the charge for a single stay remains 20p on a pay and display basis, with a maximum permitted stay of 24 hours. In respect of this and all other pay and display car parks mentioned above a standard charge is to become payable for any vehicle waiting in the car park during charging hours for any period for which the

specified charge has not been paid in advance. The standard charge is to be £6 payable within one month, or £3 if it is paid within 14 days; those disabled drivers who are not liable to pay the specified charge shall not incur the standard charge.

(d) The former car park at South Road, Southall, is to be deleted from the Order.

(e) The car park at Bayham Road, W.13, will continue to be open all hours all week to vehicles not exceeding 2½ tons in weight or 6 feet 6 inches in height, and the maximum permitted stay remains 24 hours. It is, however, to be a free car park subject to no method of control.

(f) Other provisions remain unchanged. (030)

(Various Roads, Oldham) (Bus Stops) (Clearway) (Experimental) (Extension No. 2) (County) Order 1980

Notice is hereby given that on 13th May 1980 the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to experimentally prohibit for a further six months until the 14th November 1980 all vehicles other than buses from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in any of the roads specified below when the carriageway at that stop is marked, (a) as a bus stop and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised marking"). The Minister of Transport has given his approval to the Order. The roads to which the Order relates are:

High Street from Crompton Street to Market Street. Market Street from High Street to Milnrow Road. Milnrow Road from Market Street to Smallbrook Road. Wren's Nest terminus from Smallbrook Road to Milnrow Road.

Ripponden Road from Huddersfield Road to Coleridge Road. Coleridge Road from Ripponden Road to Longfellow Crescent. Longfellow Crescent from Coleridge Road to Sholver Lane. Sholver Lane from Longfellow Crescent to Pearly Bank. Pearly Bank from Sholver Lane to and including the bus turning area. Hollins Road from Heron Street to Copster Hill Road. Copster Hill Road from Hollins Road to Ashton Road. Honeywell Lane from Ashton Road to Keswick Avenue. Keswick Avenue from Honeywell Lane to Fir Tree Avenue. Fir Tree Avenue from Keswick Avenue to Rosary Road. Fold View from Springwood Hall Road to Fircroft Road. Fircroft Road from Rosary Road to Fold View. Rosary Road from Fir Tree Avenue to Fircroft Road, Springwood Hall Road from Rosary Road to Fold View. King Street from Union Street to Manchester Street.

While the Order remains in force it enables the Council at any time to lay or to remove the authorised markings at or from any bus stop in a specified road or to adjust the position in that road of the authorised markings, as traffic conditions may require.

Other vehicles are permitted to wait at bus stops with authorised markings, where necessary, for the removal of an obstruction to traffic, in certain circumstances in exercise of statutory powers, in certain emergencies and for police, fire brigade or ambulance purposes.

A copy of the Order which comes into operation on 14th May 1980 and a plan showing the roads to which it relates may be inspected between 9 a.m. and 4.30 p.m. on Monday to Friday at the County Secretary's Office, County Hall (Minshull Street entrance), Piccadilly Gardens, Manchester, or at the Director of Administration's Office, Oldham Borough Council, Civic Centre, Oldham.
