GLOUCESTERSHIRE COUNTY COUNCIL

Gloucestershire County Council (Chipping Campden) (Various Roads) (Prohibition of Waiting) Order 1980

 7. Loading and unloading goods.
 8. Statutory undertakers' purposes.
- Exemptions apply for disabled persons vehicles.

3. To prohibit waiting by vehicles from 8 a.m. to 6 p.m. on Mondays to Fridays:

(i) *Moor Road—*

The east side from 15 metres north of Newlands Road to 15 metres south of Bideford Drive; the west side from 15 metres north of Falterley Road to 15 metres south of Bideford Drive.

(ii) *Newlands Road, Baguley—*

Both sides from Moor Road for a distance of 15 metres.

4. To impose one-way traffic on the following length of road:

Service road to White Moss Shops numbered 229 to 251 Charlestown Road, Blackley—

From 229 to 251 Charlestown Road in that direction (from west to east).
