### NEW TOWNS ACT 1965

*The New Town of Skelmersdale Extinguishment of Public Rights of Way Part of Harts Lane, Skelmersdale*

Notice is hereby given that the Secretary of State for the Environment, in exercise of his powers under section 23 of the New Towns Act 1965, proposes to make an Order extinguishing the public rights of way over the following highway shown coloured red on the map hereinafter referred to:

That part of Harts Lane from a point marked "D" on the map on the eastern side of Stannanought Road and running in a north-easterly direction for approximately 45 metres to a point marked "E" on the map at its junction with the boundary of Beacon Park.

A map showing the rights of way proposed to be extinguished may be inspected at the offices of the Skelmersdale Development Corporation, Pennylands, Skelmersdale, and at the Corporation's Information Centre, 55 Southway, The Concourse, Town Centre, Skelmersdale, during normal office hours.

## DEPARTMENT OF TRANSPORT

### TOWN AND COUNTRY PLANNING ACT 1971

The Minister of Transport hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of West Yorkshire) (Leeds No. 1) Order 1980", authorising the stopping up of a length of Provost Street, Leeds.

May 1980, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

### TOWN AND COUNTRY PLANNING ACT 1971

### ROAD TRAFFIC REGULATION ACT 1967, SECTION 12(1)

*The Trunk Road (Bascule Bridge, Lowestoft) (A12) (Temporary Prohibition of Traffic) Order 1980*

Notice is hereby given that the Minister of Transport proposes to make an Order on the London-Great Yarmouth Trunk Road A12.

The Order, which is being made to enable works to be carried out will be in operation, when the appropriate signs are erected from 1st June 1980 until such time as the works have been completed.

The effect of the Order will be to close the Bascule Bridge, Lowestoft, to traffic (except vehicles being used in connection with the said works).

#### *Alternative route for through traffic*

The alternative route for northbound through traffic will be from Bloodmoor Roundabout at Pakefield, via Bloodmoor Road, Elm Tree Road, Cotmer Road, Bridge Road and Gorleston Road (all of which form the A1117) to rejoin the A12 Trunk Road at Point Cottages Corton, and vice versa for southbound traffic.

Diversions for local traffic will be signposted.

### THE IMPORTED FOOD REGULATIONS 1968 (AS AMENDED)

#### *Finland: Official Certificate*

The Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales acting jointly give notice that in exercise of the powers conferred on them by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973 and 1979 (S.I. 1973 No. 1351 and S.I. 1979 No. 1426), and the Transfer of Functions (Wales) (No. 1) Order 1978 (S.I. 1978 No. 272) they hereby restrict recognition of the Official Certificate reproduced in the Schedule to the Notice published in the *London Gazette* dated 25th September 1970 for the importation of meat and casings from Finland, to the extent shown in the Schedule hereto.

The Notice published in the *London Gazette* dated 6th November 1979 is hereby revoked.
