*The London-Fishguard Trunk Road  
(Improvement at Pentre Meyrick Side Roads) Order 198*

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road at Pentre Meyrick in the county of South Glamorgan, to make under section 9 of the Highways Act 1959 an Order which will:

- (a) authorise him
- (i) to improve, raise, lower or otherwise alter parts of the unclassified Pentre Meyrick to Pencoed road and the B4268 Pentre Meyrick to Llantwit Major road;
  - (ii) to stop up part of the B4268, to be superseded by the construction of the new highway described in (iii) following;

- (iii) to construct a new highway to connect the B4268 with the Trunk Road;
- (iv) to stop up private means of access to premises; and
- (v) to provide new means of access to premises, all at Pentre Meyrick aforesaid; and

- (b) provide for the transfer of the said new highway to the County Council of South Glamorgan as from the date on which he notifies the Council that the new highway has been completed and is open for through traffic.

Copies of the draft Order and of the relevant plan may be inspected free of charge at all reasonable hours from 21st May 1980 to 2nd July 1980 at the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, and at the offices of South Glamorgan County Council, County Headquarters, Newport Road, Cardiff, and the Vale of Glamorgan Borough Council, Town Hall, Cowbridge.

Any person may not later than 2nd July 1980 object to the making of the Order, by notice to the Secretary of State, at the Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting reference WR 11/7/14 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection, it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
