Her Majesty, in exercise of the powers conferred on Her by section 3 of the Naval and Marine Pay and Pensions Act 1865 (1865 c. 73) and of all other powers enabling Her in that behalf, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered as follows:

#### Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Pay and Allowances) Order 1980.

General

- 2. The revised rates of pay and allowances set out in the Schedules to this Order shall have effect from 1st the Schedules to this Order shall have effect from 1st April 1979 except as may be specified otherwise in the said Schedules and shall be payable, subject to the regulations made by the Defence Council or the Admiralty Board on their behalf, in respect of Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines and of members of the Naval and Marine Reserves while serving or training in Her Majesty's Ships or Establishments; the said rates and allowances shall not apply to Officers appointed for time only or otherwise holding Naval rank for purposes of status only or to personnel recruited abroad for local service. The rates in the Schedules shall be read as daily rates, unless otherwise specified. as daily rates, unless otherwise specified.
- 3. Education Grants may be awarded in accordance with Schedule 1 to this Order.
- 4. Officers, Ratings and Other Ranks of the Royal Naval Reserves and Royal Marines Reserves shall receive the rates of pay shown in Schedules 5 and 6 to this Order, except that the rates shown in Schedules 2 and 3 to this Order shall apply as directed by the Admiralty Board when such persons fill complemented Active List appointments
- 5. Increments of pay for Officers of the Royal Naval Reserve and the Royal Marines Reserve shall depend on mobilised service at naval rates of pay in the confirmed or paid acting rank, or as may be provided by the Defence Council or the Admiralty Board on their behalf.
- 6. London pay shall be paid to Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines in accordance with Schedule 4 to this Order.
- 7. Revised rates of allowances and Additional Pay shall be payable in accordance with Schedule 7 to this Order.
- 8. A revised rate of Northern Ireland Additional Pay shall be payable to Officers, Ratings and Other Ranks of the Royal Navy and Royal Marines in accordance with Schedule 8 to this Order.
- A Family Maintenance grant may be made to the wives of Ratings and Other Ranks, Royal Marines during the periods when their husbands are in detention, subject to the conditions set out in Schedule 9 to this Order.
- 10. An allowance may be paid to the dependants of any Officer, Rating or Other Rank, Royal Marines who is reported to be missing subject to the conditions set out in Schedule 10 to this Order.
