Exemptions in respect of Orders (1), (3) and (4) include the loading and unloading of goods, the supply of gas, water and electricity, the setting down and picking up of passengers and in respect of disabled drivers vehicles.

Regulation Act 1967, as amended, have not been complied with in relation to the Orders they may within 6 weeks from the date on which they are made apply to the High Court for that purpose.
