TOWN AND COUNTRY AMENITIES ACT 1974

Town and Country Planning (Listed Building and Buildings in Conservation Areas) (Amendment) Regulations 1974

Town and Country Planning (Tree Preservation Order) (Amendment) and (Trees in Conservation Areas) (Exempted Cases) Regulations 1975.

Extension to Davenham Conservation Area

Notice is hereby given that the Vale District Council in pursuance of its powers under section 277 of the Town and Country Planning Act 1971 have designated those parts of the Vale Royal District described in the Schedule below as an extension to the Davenham Conservation Area.

Plans showing the Conservation Area may be inspected during office hours from Monday to Friday inclusive at:

1. The Secretary's Department, Whitehall, Hartford, Winsford;
2. The Planning Department, Over Hall, Winsford.

Attention is drawn to the effect of designation on the control of demolition of buildings and in the felling, lopping, topping or damaging of trees within a Conservation Area.

Section 277A of the Town and Country Planning Act 1971 applies to all buildings in conservation areas other than:

- (a) listed buildings (which are subject to control under other legislation);
- (b) "excepted" buildings under section 58 (2) of the Act (Churches, chapels, ancient monuments which are subject to control under other regulations);
- (c) buildings specified in a direction by the Secretary of State

and requires that any building to which section 277A applies shall not be demolished without the consent of the Secretary of State.

Section 61A of the Town and Country Planning Act 1971 applies to all trees within Conservation Areas other than trees included in Tree Preservation Orders and prohibits the cutting down, lopping, topping, uprooting, wilful

damage or wilful destruction of trees, except with consent of the Local Planning Authority or where a tree is dangerous.

SCHEDULE

To the south of the original Conservation Area, the boundary includes Davenham Hall, its parkland, a narrow woodland and hydraulic ram to the east, Park Cottage, and a small woodland to the south of the hall. The boundary then runs north, along the rear of detached houses on the eastern side of London Road, then west along the northern boundary of No. 547 London Road. It turns north along the eastern side of London Road, to include No. 539 London Road before crossing London Road to include Nos. 560 and 562 and No. 1 Fountain Road. North of the Fountain itself, the boundary also includes No. 542 London Road before continuing along the eastern part of Grovemount and turning east to cross London Road, continuing east along the northern boundary of No. 497 London Road. The boundary then turns to the north-east following and including the footpath at the rear of Nos. 487-495 London Road to join the original Conservation Area.

Aylesbury Vale District Council (Parish of Aston Clinton, Footpath No. 8) Public Path Diversion Order 1980

Notice is hereby given that on 12th May 1980, the Aylesbury Vale District Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public right of way specified in the First Schedule to this notice to a line specified in the Second Schedule of the said notice.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the Aylesbury Vale District Council Offices, The Mall, Friars Square, Aylesbury, during normal office hours.

The Order becomes operative 28 days from 22nd May 1980, but if a person aggrieved by the Order desires to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959, as amended, or on the ground that any requirement of the Act, as amended, or any regulation made thereunder has not been complied with in relation to the Order, he may, under paragraph 2 of Schedule 2 to the Act, as applied by paragraph 5 of Schedule 7 to the Act, within 6 weeks from 22nd May 1980, make an application for the purpose to the High Court.

FIRST SCHEDULE

Description of Site of Existing Path or Way

Commencing from its junction with footpath No. 10 Beechwood Way, Aston Clinton; then continuing in a south-westerly direction for a distance of approximately 300 metres to where it joins footpath No. 7 Aston Clinton. The existing path has a width throughout of approximately 1 metre.

SECOND SCHEDULE

Description of Site of Alternative Highway

Commencing at a point also adjoining Footpath No. 10 at Beechwood Way, Aston Clinton, but approximately 30 metres south-east of its existing entrance, then continuing in a south-westerly direction for a distance of approximately 40 metres, then continuing in a generally south-south-westerly direction for a distance of approximately 100 metres, then proceeding south-west turning to a south-south-westerly direction for a distance of approximately 120
