*M4 Motorway (Castleton to Coryton Section) and  
Connecting Roads Scheme (Side Roads) (Variation)  
Order 19*

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the part of the M4 Motorway which will be situated between Rhiwbina in the county of South Glamorgan and Castleton in the county of Gwent, to make an Order under sections 13, 18 and 286 of the Highways Act 1959, section 27 of the Local Government Act 1966 and section 62 of the Highways Act 1971, which will authorise him to vary the powers conferred by "The M4 Motorway (Castleton to Coryton Section) and Connecting Road Scheme (Side Roads) Order 1975" (hereinafter referred to as "the 1975 Order") and enable him:

1. (a) To divert footpath No. 47 (Whitchurch PH);
- (b) to construct a new length of highway leading to the new private means of access to Pant-rhiw-goch Farm, Michaelston-y-Vedw; and
- (c) to create the formerly stopped-up portion of the old Castleton to Michaelston Road as new private means of access to Pant-rhiw-goch Farm, Michaelston-y-Vedw.
2. To provide for the transfer of each of the said new highways to the highway authority specified therefor in the Order as from the date on which he notifies that authority that the new highway has been completed and is open for traffic.

CLEAN AIR ACT 1956

*The South Tyneside No. 7 Smoke Control Order 1980*

Notice is hereby given that the Council of the Borough of South Tyneside in exercise of the powers conferred on them by section 11 of the above-mentioned Act on 30th May 1980, made an Order entitled The South Tyneside No. 7 Smoke Control Order 1980, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.
