7062/80. (COM (80) 275.) Proposal for transfer of appropriation No. 3/80 from one chapter to another within the Commission's budget estimates for the financial year 1980 (emergency aid for Zimbabwe).

- 7104/80. (COM (80) 232.) Proposal for a Council Regulation laying down general rules on certain distillation operations for wines and the by-products of wine-making.
