##### HIGHWAYS ACTS 1959 TO 1971

*The Cardiff-Llangurig Trunk Road (Abercynon-Pentrebach Diversion Side Roads) Order 198*

*The Cardiff-Llangurig Trunk Road (Abercynon-Pentrebach Diversion Side Roads Order 1979) (Variation) Order 198*

The Secretary of State for Wales hereby gives notice that he proposes, in relation to the above-mentioned Trunk Road between Abercynon and Pentrebach in the county of Mid Glamorgan, to make:

1. An Order under section 9 of the Highways Act 1959, sections 3 and 62 of the Highways Act 1971 and section 27 of the Local Government Act 1966 which would:

(a) authorise him:

- (i) to improve, raise, lower or otherwise alter highways,
- (ii) to stop up highway,
- (iii) to construct new highways,
- (iv) to provide new means of access to premises, and
- (v) to carry out temporary diversion of highways and the trunk road to enable highways to be realigned over or alongside the new trunk road, all between Abercynon and Pentrebach aforesaid, and

(b) provide for the transfer of the said new highways to the County Council of Mid Glamorgan as from the date on which the Secretary of State notifies the Council that the new highways have been completed and are open for through traffic, and

2. An Order under sections 9 and 286 of the Highways Act 1959, section 27 of the Local Government Act 1966, and sections 3 and 62 of the Highways Act 1971, which would authorise him to vary the Cardiff-Llangurig Trunk Road (Abercynon-Pentrebach Diversion Side Roads) Order 1979 (hereinafter referred to as "the 1979 Order") so as to enable him:

(a) to make variations to the powers contained in the 1979 Order relating to:

- (i) the improvements, raising, lowering or other alterations to highways,
- (ii) the stopping up of highways,
- (iii) the construction of new highways,
- (iv) the stopping up of private means of access to premises, and
- (v) the provision of new private means of access to premises,

all between Abercynon and Pentrebach aforesaid, and (b) provide for the transfer of the said new highways to the County Council of Mid Glamorgan as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

WR11/5/15 for the draft Side Roads Order and WR11/5/16 for the draft Variation Order and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.
