Notice is hereby given that the above-named Order (here-inafter referred to as "the Order") made on 25th April 1980 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Leominster District Council as an unopposed Order.

The effect of the Order, if confirmed without modification will be to divert two lengths of footpath one of which being part of the existing public footpath No. 156 on the Definitive Map commences at a point 130 feet or thereabouts north-east of the south-west corner of Parcel No. 8523 National Grid Sheet SO4859 and runs therefrom in a north-easterly direction for a distance of 185 feet or thereabouts and thence in a north-westerly direction for a distance of 305 feet or thereabouts and thence in a north-easterly direction for a distance of 330 feet or thereabouts to its junction with the existing public footpath numbered 6 on the Definitive Map, this length of footpath will be diverted to a new line commencing at a point 130 feet or thereabouts north-east of the south-west corner of the said Parcel No. 8523 and running there from in a generally northerly direction for a distance of 360 feet or thereabouts and then generally in a north-easterly direction for a dis-tance of 470 feet or thereabout to join the existing public footpath numbered 6 on the Definitive Map along the line marked A-B, B-C on the map annexed to the Order.

The other length of footpath being part of the existing public footpath numbered 6 on the Definitive Map and situate at Leominster in the County of Hereford and Worcester commences at its junction with the existing public footpath numbered 7 on the Definitive Map and runs therefrom in a north-westerly direction for a distance of 330 feet or thereabouts to its junction with the existing public footpath numbered 156 on the Definitive Map. This length of footpath will be diverted to a new line commencing at a point on the existing public footpath numbered 7 on the Definitive Map approximately 60 feet north of the existing junction of the public footpath numbered 6 and 7 on the Definitive Map and running therefrom in a westerly direction for a distance of 100 feet or thereabouts and thence in a north-westerly direction The other length of footpath being part of the existing feet or thereabouts and thence in a north-westerly direction for a distance of 160 feet or thereabout and thence in a westerly direction for a distance of 120 feet or thereabouts to join the existing footpath numbered 6 on the Definitive Map along the line marked D-E, E-F on the Map annexed to the Order.
