

The effect of the Order, if confirmed without modifications, will be to divert that part of footpath Hurst Green 6 running from a point immediately north of Holy Trinity Church to a point approximately 175 feet further west by the formation of an alternative path leaving and rejoining the existing path in a shallow arc approximately 8 feet north of the existing path at the apogee of the arc.

A copy of the Order and the map contained in it has been deposited at and may be inspected free of charge at The Watch Oak, Battle, East Sussex, during normal office hours.

Any objection or representation concerning the Order may be sent in writing to the undersigned not later than 21st July 1980 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Council may instead of submitting the Order to the Secretary of State for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.

Public Footpath V 47 St. Martin's Down, Wroxall, Public Path Diversion Order 1980

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 9th June 1980 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the South Wight Borough Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert the public right of way beginning at a point 94 metres north-west of its junction with footpath V 33 east of Cook's Castle and proceeds in a westerly direction for 55 metres to join bridleway V 34; to a line beginning at the same point and proceeding in a north-westerly direction for 30 metres following the north-east boundary of the new reservoir to join the diverted route of bridleway V 34 near the north-east corner of the reservoir.

Public Bridleway V 34 St. Martin's Down, Wroxall Public Path Diversion Order 1980

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 9th June 1980 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the South Wight Borough Council as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert the public right of way beginning at a point 40 metres west of the gate at its junction with public bridleway NC 30 north-east of Cook's Castle and proceeding in a west-south-west direction climbing a bank and proceeding across a plateau for a total distance of 93 metres; to a line beginning at the same point and proceeding in a westerly then south-westerly direction following the north boundary of the new reservoir for a distance of 95 metres to rejoin the existing bridleway.

The Borough of North Wolds (Kilham) Public Footpath Diversion Order 1980

The effect of the Order as confirmed is to divert the public right of way commencing at a point in the field immediately to the east of fields O.S. 0055 and 0046 in the Parish of Kilham in the County of Humberside and leading in a generally northerly direction for a distance of approximately 165 metres to a point on the southern side of Back Lane, Kilham, being part of footpath number 7 in the Parish of Kilham on the Definitive Map of Public Rights of Way to a line commencing at a point in the field immediately to the east of fields O.S. 0055 and 0046 in the Parish of Kilham in the County of Humberside and leading in a generally north-north-easterly direction for a distance of 175 metres to a point on the southern side of Back Lane, Kilham, being part of footpath number 7 in the Parish of Kilham on the Definitive Map of Public Rights of Way and being a width of not less than 4 feet throughout its length.
