HIGHWAYS ACTS 1959 TO 1971

-Bangor (Menai Suspension Bridge) Trunk Road The Fishguard-(Morfa Improvement) Order 1980

and The Fishguard-Bangor (Menai Suspension Bridge) Trunk Road (Morfa Improvement Side Roads) Order 1980

The Secretary of State for Wales hereby gives notice that in relation to the above-mentioned Trunk Road at Morfa in the county of Dyfed, he has made under the Highways Act 1959:

- 1. An Order under section 7, which provides that a road which he proposes to construct at Morfa in the county of Dyfed shall become a trunk road as from the date when the Order comes into operation.
- 2. An Order under section 9 of the Highways Act 1959, authorising him:

(a) to stop-up highways;

(c) to stop-up private means of access to premises; and (c) to provide new means of access to premises;

(c) to provide new means of access to premises; all at Morfa, Dyfed aforesaid. Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways

Act 1959 or the Highways Act 1971 or on the ground that any requirement of either of those Acts, or of regulations made thereunder, has not been complied with in relation to the Orders, may within 6 weeks from 30th June 1980 apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein. *P.
