And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Charles Nedderman Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this order in his official name in the *London Gazette*

And it is ordered that the petitioners the said Charles Nedderman Limited and Iris Lily Nedderman do jointly and severally pay to the Registrar of Companies his costs of the said petition such costs to be on the High Court Scale and on the Common Fund basis and to be taxed if not agreed
