Imposition of a 40 m.p.h. and 50 m.p.h. Speed Limit

Notice is hereby given that the Minister of Transport has made an Order under sections 74 (1) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the Derby-Macclesfield-South of Stockport Trunk Road (A523) known as London Road North at Poynton in the county of Cheshire and Macclesfield Road at Hazel Grove in the county of Greater Manchester county of Greater Manchester.
