*The Newtown-Machynlleth Trunk Road (Improvement at Gwern-y-Bwlch) Order 1980, and the Newtown-Machynlleth Trunk Road (Improvement at Gwern-y-Bwlch Side Roads) Order 1980.*

The Secretary of State for Wales hereby gives notice that in relation to the above mentioned Trunk Road at Gwern-y-Bwlch in the County of Powys, he has made under the Highways Act 1959.

1. An Order under section 7 which provides:

(a) that a road about 220 metres in length which he proposes to construct at Gwern-y-Bwlch in the county of Powys shall become a trunk road as from the date when the Order comes into operation and

2. an Order under section 9 of the Highways Act 1959 authorising him:

(a) to stop up the length of Trunk Road to be superseded by the construction of the road described at 1 above.

(b) to construct two new highways

(i) to connect the Unclassified Road to Gwern-y-Bwlch to the new trunk road described at 1 above

(ii) to connect footpath No. 63, via a new highway which will be a footpath, to the new highway described in (b)(i) above, and

(c) to provide a new means of access between field OS No. 1453 and the new highway described in (b)(i) above

all at Gwern-y-Bwlch aforesaid and to provide the transfer of each of the said new highways to the County Council of Powys as from the date on which he notifies the Council that the new highways have been completed and are open for through traffic.

Copies of the Orders and of the relevant plans have been deposited at the Welsh Office, Cathays Park, Cardiff and at the offices of Powys County Council, Highways Area Office, The Park, Newtown, Powys and Montgomery

District Council, Area Office, Machynlleth, Powys, where they are open to inspection free of charge at all reasonable hours.

Copies of the section 7 Order, the title of which is "The Newtown-Machynlleth Trunk Road (Improvement at Gwern-y-Bwlch) Order 1980" (S.I. 1980 No. 912) can be purchased through any bookseller or direct from government book shops (HMSO).

Any person aggrieved by the Orders and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1959 or the Highways Act 1971 or on the ground that any requirement of either of those Acts, or of regulations made thereunder, has not been complied with in relation to the Orders, may within 6 weeks from 25th July 1980 apply to the High Court for the suspension or quashing of the Orders or of any provision contained therein.
