HIGHWAYS ACTS 1959 TO 1971

The Winchester-Preston Trunk Road (A34) (Whitway Diversion Side Roads) Order 19

The Minister of Transport hereby gives notice that he proposes in relation to the above-mentioned Trunk Road and a new trunk road to be constructed by him at Whitway in the county of Hampshire, to make under section 9 of the Highways Act 1959 an Order which will-

(a) authorise him-

(a) authorise nim—

(i) to improve, raise, lower or otherwise alter highways;

(ii) to stop-up highways;

(iii) to construct new highways;

(iv) to stop-up private means of access to premises; and

(v) to provide new means of access to premises; and
all on or in the vicinity of the route of the above-mentioned

Trunk Road and new trunk road; and

(b) provide for the transfer of each of the said new highways to the County Council of Hampshire as from the date on which he notifies that authority that the new highway has been completed and is open for through traffic.
