

passageway in front of Woodward's Cottages, to Bridge Street. From there the boundary follows the southern edge of Bridge Street eastwards for 30 metres, it runs to the rear of properties on the northern and western sides of High Street, The Cross and Liverpool Road, from 37 High Street to 32 Liverpool Road inclusive (1, 3 and 5 Raby Road are also included). From the junction of Cross Street and Liverpool Road the boundary runs on the east side of Liverpool Road up to and including the Malt Shovel Public House.

A map of the designated area has been deposited at the offices of the Ellesmere Port and Neston Borough Council at Whitby Hall, Ellesmere Port and at the Town Hall, Neston and may be inspected during normal office hours.

The purpose of the designation is to preserve and enhance the character and appearance of this area of special architectural or historical interest and to ensure that special regard is paid to the architectural and visual qualities of the designated area as a whole when proposals for development are under consideration. In accordance with section 61A and 277A of the Town and Country Planning Act 1971 respectively, subject to certain exceptions, notice has to be given to the Local Planning Authority in respect of a proposal to cut down, top, lop or uproot any tree in the designated area and consent is required for the demolition of all non-listed buildings in the designated area.

Ribble Valley Borough Council (Footpaths Nos. 25 and 26 Wilpshire) Public Path Diversion Order 1980

Notice is hereby given that on 4th August 1980, the Ribble Valley Borough Council confirmed the above-named Order.

The effect of the Order, as confirmed without modification, is to divert that portion of footpath No. 26 Wilpshire commencing 36 yards from its present junction with footpath 20 at point A on the plan attached to the Order and running in a northerly direction for a distance of approximately 116 yards to point B, to a line from point B in a southerly direction for a distance of approximately 90 yards to point C and thence in a south-easterly direction for a distance of approximately 12 yards to point D.

The effect of the Order as confirmed without modification is also to divert that portion of footpath No. 25 Wilpshire commencing from its present junction with footpath No. 26 Wilpshire at point E for a distance of approximately 40 yards to point F to a line following the proposed new estate road which is a continuation of Hollowhead Avenue.

A copy of the confirmed Order and the map contained in it has been deposited and may be inspected free of charge, at the Council Offices, Church Walk, Clitheroe, between normal office hours.

The Order becomes operative when it has been certified by the Ribble Valley Borough Council that the alternative highway has been created to the reasonable satisfaction of the Council, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any Regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 244 of the Town and Country Planning Act 1971, within 6 weeks from the date of publication of this notice make application for the purpose to the High Court.
